The Syllabus has been built to allow basic understanding of these instruments and the related financial market segments, therefore providing the required competence level for existing or future financial markets professionals.



There are 5 core subject areas (and Topic Baskets) in the ACI Dealing Certificate (New Version) whose detailed coverage is appended:

- Financial Markets Environment
- Foreign Exchange
- Rates (Money and Interest Rate Markets)
- FICC (Fixed Income, Currency and Commodities) Derivatives
- Financial Markets Applications

In each ACI Dealing Certificate New Version Exam, a candidate will be asked 70 multiple choice test questions to be answered in two hours. The computer-based exams will be offered in selected test centres all over the world. In Oman, CBFS is the Test Centre.
